<b>5. Title, number of pages and language(s) of the notified document:</b> Ministerial Decree No.134 for the year 2014 mandating ES 3578-4/2006 "Fibre boards- specifications Part 4: Requirements for hard boards" (2 pages, in Arabic).
<b>6. Description of content:</b> This decree mandates that the producers and importers of hard boards must comply with the requirements set in ES 3578-4/2006. This Egyptian standard is concerned with the requirements that must be met in hard boards and previously defined in (EN 316). Noting that the values contained in this standard are relevant to the characteristics of the product and are not the values for use in design calculations. Worth mentioning is that the Egyptian standard is in accordance with EN 622-2/2004.
<b>7. Objective and rationale, including the nature of urgent problems where applicable:</b> Protection of human Safety.
<b>8. Relevant documents:</b> - Ministerial Decree No.134/2014; - EN 622-2/2004.
