International Cooperation

Presidential Decree No. 2 in 1957 has been issued to establish the Egyptian Organization for Standardization representing Egypt in the international and regional standardization arena and in the same year EOS became an ISO member.

- EOS performs a wide activity at the international and regional level, it is a member of the following organizations:
- ISO Council for group 3 for the period 2023-2025
- ARSO Council for the period 2023-2025
- AIDSMO Executive council and general assembly as well as the High Arab committee for standardization, strategy, conformity assessment SMIIC Council member for the period 2022-2024
- Companionship with the European Committee for Standardization (CEN)



"Egyptain Standards & climate change



Egyptian standards support the transformation of climate action from commitment to an effective impact and help government and industry to adapt and mitigate the impacts of climate change.

EOS Develops multiple climate related standards to minimize its negative impacts in many sectors such as (energy, Recycling, environment, water, soil, air.....etc) aligned with the UN SDGs and Egyptian strategy for sustainable development 2030.



The role of EOS in motivating the effective implementation of climate action-related standards

"Energy sector"

- Energy related Standards are Focusing on increasing energy efficiency, encouraging the transition to the use of renewable energy sources, and supporting sustainable industrialization through standards that meet quality, safety, and sustainability requirements.
- The Ministerial Decrees No 171/2011 & 912/2017 for regulating Energy Efficiency labeling of Electric Appliances & lightening systems prior to introduction into the Egyptian Market.





EOS established an Energy efficiency unit (EEU) aiming to :

- Enforce the producers and importers to place energy efficiency labels on Electric Domestic appliances and electric lamps in order to match their data and verify their energy consumption level prior introduction to the Egyptian markets.
- Registration of accredited bodies and laboratories that grant conformity certificates or test reports regarding energy efficiency.
- EEU issuing Energy Efficiency
 Labeling for Electric Domestic
 Appliances (Par code &planned Qr
 Code) for facilitating market
 surveillance.
- In cooperation with the UNDP, EOS has built a Solar Power Station on its premises that covers 58 % of its energy consumption.
- EOS Collaborate with UNIDO to develop solar heaters relatedstandards in order to use renewable energy sources instead of fossil fuels

The environmental performance Label for paints aims to measure the level of harmful emissions and then classify them according to MRLs of Volatile organic compounds (VOC), Heavy Metals (including lead), and Formaldehyde.

Recycling





- Water efficiency Label for sanitary ware products (tapes, shower,..etc) to ensure the efficient use of water for the labeled items.

- Some of ES (Soil quality, Fertilizer and soil conditioners, Air quality.....etc)




