<b>6. Description of content:</b> The Ministerial Decree no. 692/2015 mandates that the producers and importers must comply with ES 7842/2014. Producers and importers are given a transitional period of six months.  This standard applies to Uniform provisions concerning the approval of gas-discharge light sources for use in approved gas-discharge lamp units of power-driven vehicles.  This standard complies with UNECE Regulations No. 99.
