<b>6. Description of content:</b> This decree states that compliance with the following Egyptian standard is mandatory.  ES 7086/2010: Uniform provisions concerning the approval of audible warning devices and of motor vehicles with regard to their audible signals (English).  This standard applies to:  I. Audible warning devices, operated by direct current or compressed air, which are intended for fitting to motor vehicles with the exception of motor cycles;  II. The audible signals of motor vehicles, with the exception of motorcycles.  The standard is identical with the latest version of UNECE Vehicle Regulations – 1958 Agreement Regulation No. 28 and all its amendments
