ES 7086/2010: Uniform provisions concerning the approval of audible warning devices and of motor vehicles with regard to their audible signals (English).

This standard applies to:

- I. Audible warning devices, operated by direct current or compressed air, which are intended for fitting to motor vehicles with the exception of motor cycles;
- II. The audible signals of motor vehicles, with the exception of motorcycles.

The standard is identical with the latest version of UNECE Vehicle Regulations – 1958 Agreement Regulation No. 28 and all its amendments
