This addendum concerns the notification of the Ministerial Decree No. 502 /2023 (4 pages, in Arabic) that gives the producers and importers a six-month transitional period to abide by the Egyptian Standard ES 8742 for "Furniture - Strength, durability and safety – requirements for domestic tables"; (13 page(s), in Arabic)

It should be noted that the draft of this standard was formerly notified in G/TBT/N/EGY/350 dated 22 March 2022.

Worth mentioning is that this standard is technically identical with EN 12521 : 2015.

Producers and importers are kept informed of any amendments in the Egyptian standards through the publication of administrative orders in the official gazette.
