This standard cancels and supersedes ES 4761/ 2005 and ES 4759 /2018

It should be noted that Ministerial Decree No. 423/2005 (25 pages, in Arabic) which was formerly notified in G/TBT/N/EGY/3 dated 14 December 2005 mandated among others the earlier version of this Standard and the draft of the Egyptian Standard ES 4759 was formerly notified in G/TBT/N/EGY/3/Add.11 dated 10 January 2018.

Worth mentioning is that this draft standard is technically identical with ISO 7494-1/2018
