Description: Products covered: Concrete and concrete products (ICS code(s): 91.100.30); Construction of railways (ICS code(s): 93.100)

This addendum concerns the notification of the Ministerial Decree No.141/2024 (2 pages, in Arabic) that gives the producers and importers a six-month transitional period to abide by the Egyptian Standard ES 8801-4 for "Railway applications - Track - Concrete sleepers and bearers – Part: 4 – Pre stressed bearers for switches and crossings"; (22 page(s), in Arabic)

It should be noted that the draft of this standard was formerly notified in G/TBT/N/EGY/458 dated 12 March 2024.

Worth mentioning is that this standard is technically identical with EN 13230-4:2016+A1: 2020

Producers and importers are kept informed of any amendments in the Egyptian standards through the publication of administrative orders in the official gazette.
