Description: Products covered: Ventilators. Fans. Air-conditioners (ICS: 23.120); Heat pumps (ICS 27.080)

This addendum concerns the notification of the Ministerial Decree No.502/2023 (4 pages, in Arabic) that gives the producers and importers a twelve-month transitional period to abide by the Egyptian Standard ES 3795 " energy efficiency label requirements for air conditioner- room air conditioner (window - split) " (25 pages, in Arabic).

This standard cancels and supersedes the following standards: ES 3795-1/2016,ES 3795-2/2017, ES 3795-5/2018

It should be noted that the Ministerial Decree No. 1098/2016 (1 page, in Arabic) which was formerly notified in G/TBT/N/EGY/68/Add.1 dated 22 June 2017, the Ministerial Decree No. 1307/2017 (2 pages, in Arabic) which was formerly notified in G/TBT/N/EGY/68/Add.4 dated 21 February 2018 and the Ministerial Decree No. 102/2019 (2 pages, in Arabic) which was formerly notified in G/TBT/N/EGY/68/Add.6 dated 14 May 2019 mandated among others the earlier versions

of this Standard and its draft was formerly notified in G/TBT/N/EGY/68/Add.7 dated 14 November 2023.
