This addendum concerns the notification of the draft of the Egyptian Standard ES 1562 for" liquid synthetic detergents for manual dishwashing" (10 pages, in Arabic).

This standard cancels and supersedes its last version in 2015 and its partial amendment in 2023.

It should be noted that the Ministerial Decree No. 535/2015 (2 pages, in Arabic) which was formerly notified in G/TBT/N/EGY/90 dated 20 August 2015, the Ministerial Decree No. 499 /2023 (4 pages, in Arabic) which was formerly notified in G/TBT/N/EGY/90/Add.1 dated 11 March 2024, mandated among others the earlier versions of this Standard.
